BASIC CRITERIA FOR ACHIEVING THIS SELECTION ARE:

- A sincere, demonstrated commitment, motivation and interest to serve in the community.
- Interest in seeking key volunteer, public office, board duties, or commission leadership roles.
- Potential or existing opportunities for advancement to top leadership positions within their own organization, which in turn may play a significant role in the community.
- Commitment to the necessary time and effort to complete the program which includes attending all the dates listed below, as well as completing homework and group assignments.

INSTRUCTIONS (Important - read prior to completing the application)

- Must complete everything on application in space provided - NO attachments will be considered.
- All applications are subject to confidential evaluation.
- Only 30 participants will be accepted from the applications.
- If you are not selected to participate in this LEADERship Martin County series, you are invited to resubmit an application at a future date.
- Applications must be received by June 15, 2018. Selected applicants will be notified by August 6, 2018

TUITION

- The cost of the LEADERship Martin County Program is \$1,095.00 per participant if you or your employer are a member of the Stuart/Martin County Chamber of Commerce (the program sponsor). Non-member tuition is \$1,695.00. Tuition is due August 17, 2018. Tuition covers the cost of meals, transportation, retreat and graduation during the ten-month program session. The tuition may be tax deductible as a business expense; consult your tax advisor.
